

ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I hereby assume all risks of participating in the Winter Gym Training being offered through the North Allegheny Soccer Club, including, but not limited to, any risks that may arise from any negligence or carelessness on the part of the below-identified entities and persons hereby released, from any dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

I acknowledge that participation in the Winter Gym Training and the use of the facilities and playing areas associated with the Winter Gym Training carry with them the risk of personal injury, disability, death, property damage, and property theft.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the North Allegheny Soccer Club and the organizers of the Winter Gym Training in which my minor child or I may participate, and that it will govern my actions and responsibilities relative to the Winter Gym Training.

In consideration of the North Allegheny Soccer Club permitting my minor child and me to participate in the Winter Gym Training and use the facilities and playing areas associated with the Winter Gym Training, and with the intent to be hereby legally bound, I expressly agree to the following on behalf of my minor child, myself, my executors, administrators, heirs, next of kin, successors, and assigns:

(A) I WAIVE, RELEASE, AND DISCHARGE the North Allegheny Soccer Club, its coaches, agents, representatives, volunteers, and members, as well as the owners of the facilities being used for the Winter Gym Training, from any and all liability, including, but not limited to, any liability, claims or damages arising from the negligence or fault of the above-identified entities or persons hereby released, for any personal injury, disability, death, property damage, property theft, or actions of any kind whatsoever, which may hereafter occur to my minor child or me, relating to any participation in the Winter Gym Training or the use of the facilities and playing areas associated with the Winter Gym Training.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the North Allegheny Soccer Club, its coaches, agents, representatives, volunteers, and members, as well as the owners of the facilities being used for the Winter Gym Training, from and/or based upon any liabilities, claims or damages relating to any participation in the Winter Gym Training or the use of the facilities and playing areas associated with the Winter Gym Training, whether caused by negligence or otherwise.

I CERTIFY THAT I HAVE READ THIS DOCUMENT, AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT, AND I SIGN IT ON MY OWN FREE WILL.
